The Worcester County 4-H/FFA Fair Board would like to invite you to display your product at the 2017 Worcester County Fair. The Fair will be **June 23 – 25, 2017** at Byrd Park in Snow Hill. **Please note the new date.**

The Vendor spaces are 20 feet by 20 feet. You must supply your own tables, tent, and chairs. Electric is available if desired. The fee for each space is \$50.00.

**Set-Up Time: Thursday, June 22, 2017 from 3 p.m. until 8 p.m.**  
**Friday, June 23, 2017 from 8 a.m. until 10 a.m.**

<b>Hours of Operation: Friday, June 22, 2017</b>	<b>10:30 a.m. – 8:00 p.m.</b>
<b>Saturday, June 24, 2017</b>	<b>10:00 a.m. - 8:00 p.m.</b>
<b>Sunday, June 25, 2017</b>	<b>11:00 a.m. - 4:30 p.m.</b>

We will be giving you a 10% discount on your Vendor Fee if you participated in the 2016 Worcester County Fair.

Vendors must set up booth during designated times.

Vendors must release from any liability for injuries or losses associated with the Worcester County Fair, the Fair Board, the Town of Snow Hill, and its members and associates. Any Vendor providing rides must submit proof of liability insurance that names the Worcester County Fair and the Town of Snow Hill as parties also covered. Vendors shall not close before the end of operating hours on any fair day without the consent of the fair. You must remain open for all three days of the fair during the hours of operation.

Vendors will only be permitted to have one vehicle parked at each booth. All others must be parked in designated Fair parking areas.

24 hour Security is provided Thursday - Sunday by the Snow Hill Police Department.

**Final Date for application and payment is June 10, 2017.**

If you are providing an auction item, it must be given to a Worcester County Fair Staff person at set up time. Please provide your business information with the item for proper recognition of your donation.

There will be a \$10.00 late fee for any applications received after the deadline.

There will be a \$50.00 charge on all returned checks.

Refunds will be given if a request is made in writing by June 1, 2017. There will be a service fee of \$25.00 deducted from each refund.

A confirmation letter will be sent to you once your payment is recorded in the Worcester County Fair bank account.

We hope you will take advantage of this event. We advertise through local papers, radio stations, on our website, and through various internet "events" sites, as well as through the Worcester County Fair Premium Catalog and brochures which are distributed throughout Worcester, Somerset, and Wicomico counties.
